As a leading independent think tank, the Oakland Institute brings fresh ideas and bold action to the most pressing social, economic, and environmental issues of our time.

Our rigorous research, communications and advocacy strategy - initiated at the request of communities from around the world seeking support for land rights, protection of the environment, and human rights - held governments, international financial institutions, and corporations accountable.

A sampling of 2020 accomplishments includes the following:

Our Land Our Business Campaign: Following 2019 attack on land rights, we exposed the global wave of privatization of natural resources through Driving Dispossession. Country case studies-Ukraine, Zambia, Myanmar, Papua New Guinea, Sri Lanka, and Brazil-detailed how governments are privatizing land and the key role played in it by the World Bank. In Zambia, Bank's partnership with a subsidiary of the US-based online retailer Overstock.com, is using blockchain technology for land titling to "unlock trillions of dollars in global mineral reserves." In Ukraine, the economic fallout from the pandemic was used to coerce "Europe's breadbasket" into putting agricultural land into land markets. Widespread media coverage of the report helped inform current legislation to target deforestation and improve the sustainability of global supply chains. At the request of partners, a condensed educational resource This is Our Land, which debunks myths around benefits of privatizing land, is now available.

Dismantling the False Development Narrative: Building on our work since 2011, on the impact of logging and palm oil plantations in Papua New Guinea, From Extraction to Inclusion, a joint publication with Jubilee Australia and Act Now, analyzed PNG's development performance since independence. Revealing how multinational corporations externalize social and environmental costs and repatriate most profits, the report detailed important policy shifts like halting attacks on customary land tenure and increased log export tax - for the government to put people and the environment first.

As a result of our advocacy, Rimbunan Hijau, the largest logging company in PNG - exposed by the Institute for massive tax evasion - ceased logging activities in the country. In partnership with local groups, we continue to push for a "development" path that prioritizes communities and the planet.

Holding the Powerful Accountable

Nicaragua: Following a direct ask for support from the impacted communities in the North Caribbean Coast (RACCN), Nicaragua's Failed Revolution documented the land rights struggle of the Indigenous and Afro-descendent communities - bringing international attention, while building pressure on actors driving this dispossession.

We exposed the drivers - foreign gold mining firms, logging and cattle ranching industry, and prominent Nicaraguan officials. The report generated millions of media impressions through coverage in the New York Times, Guardian, Le Monde, Washington Post, ABC News, and MongaBay, and the Spanish media. PBS

NewsHour segment, The Cost of Beef, exposing Nicaragua's increased beef exports to the US are enabled through violence against the Indigenous, resulted in the Institute briefing Congressional offices and the State department.

Report launch via webinars, English (17k views) and Spanish (40k views), was attended by public officials from the Congressional offices, UN agencies, US State Department, journalists, academics, and civil society groups. Our advocacy yielded stunning results. UN Special Rapporteur on human rights defenders sent a letter to the Nicaraguan government calling for a full investigation into November 2020 murder of a Mayangna leader challenging illegal gold mining and forestry operations; and the World Bank's Forest Carbon Partnership Facility dropped Nicaragua from its portfolio (US\$55 million in funding for the reduction of deforestation).

Grueling research and advocacy requires perseverance. So does the advocacy around communal land rights - which runs counter to western notions of private property. Amidst the pandemic, our partners faced the largest public health and humanitarian crisis, along with the huge threats to democracy and a massive slide towards authoritarianism. Despite these challenges, we increased the use of on-line technology to provide a platform for the voices of land defenders through webinars and podcasts; continued advocacy, and more.
