Refer to my letter dated 06/6/2017 Mondorosi welcome you for the development project as per your request.

As you know Mondorosi is one of the villages with the case at the Court of appeal of Tanzania against TCL one of Thomson company and which Thomson safari is involved in the land dispute, the goal of the community and the villagers of Mondorosi are to get their land back restitution and not otherwise.

First of all, my letter to your application should not be used in any way neither our relationships to the proceedings of the case at court since the interests of the people of Mondorosi are at risk when their land is taken by Thomson safari through their company TCL will not be returned.

With this letter, I and the village Government/council of Mondorosi we recommend the projects you want to provide should pass or handle by the districts council considering that we don't want to see anything to interfering or affecting the court proceedings.

Just to put you on board that Thomson Safari company has been using our land for almost eight years without any single benefit taken to mondorosi community which is contrary to the wildlife laws and investment laws.
