**RE: REQUEST FOR INFORMATION ON THE CONSTRUCTION OF 15 KM**  
**KAMNAROK ELECTRIC FENCE AND ASSOCIATED WORKS**

Kituo Cha Sheria (hereinafter KITUO) is the oldest legal non-governmental organization in Kenya, whose mission is to provide general legal education to the Kenyan people through the delivery of civic education programmes, legal aid, and strategic public interest litigation as well as monitoring the implementation by States, of the constitutional provisions on human and peoples' rights through regular research and reporting.

We have been approached by members of Kamnarok Farmers Group, who are our clients for legal advice and possible representation:

They have brought to our attention of the fact that the Kenya Wildlife Service wishes to erect the 15km Kamnarok electric fence. The clients have placed in our hands tender documents for the construction of the 15km Kamnarok electric fence and associated works.

They further inform us that they had written letters to your offices dated 30<sup>th</sup> November 2023 which are yet to be responded to.

We are hence writing to reiterate the concerns that the community continues to hold and to which we wish you to furnish us with information:

- a) Whether the aforesaid fencing takes into account that there are families whose homes, grazing land and cultivation land and generally livelihood are likely to be affected?
- b) The affected area has schools and the education of the children is likely to be compromised?
- c) Whether in fencing will take into account the need to compensation, provision of alternative land and relocation of public schools?
- d) Whether the community can be engaged in this whole exercise?

In this regard, the community feels that it ought to have been consulted and or involved before the whole exercise of fencing takes place.

The community feels that it is ready to engage you with a view of getting an amicable solution.


